



# 36<sup>th</sup> Annual McHenry Women's Invitational

McHenry Country Club • McHenry, IL

## ELIGIBILITY

Entry is open to women amateur golfers who are 18 and older by August 2, 2010 and have an established USGA 18-hole handicap index of 26.9 or less. Handicaps will be frozen as of July 15, 2010. Any entrant whose handicap exceeds 26.9 by that revision will be withdrawn from the tournament and her entry returned.

## ENTRY DEADLINE FORMAT

Entries will be accepted from the applicants with the lowest handicaps until July 20, 2010 or until the field of 144 players is full. **NO CANCELLATION REFUNDS AFTER JULY 20, 2010.**

The tournament format is 36 holes of stroke play with flights determined by handicap. The Champion will be the player returning the lowest 36-hole gross score regardless of flight. First place low gross ties in any flight will be resolved by sudden death playoff immediately following play. All other ties will be determined by scorecard playoff.

## PRIZES

The following prizes will be awarded at the Awards Banquet immediately following play on August 3rd. The number of flights and number of prizes per flight will be determined by the size of field.

## ENTRY FEE

The entry fee of \$190 includes two tournament rounds with full use of the practice facilities on tournament days. The fee also includes a continental breakfast each day (or a bag lunch for those with afternoon tee times), unlimited Pasta Bar from 3:30-6:30 pm on Monday, and the Awards Banquet following play on Tuesday. Live entertainment will be provided in the clubhouse from 5-9 pm on Monday. Players and their guests are encouraged to stay and enjoy the facilities and hospitality of McHenry Country Club. Guests are welcome at all hospitality events. Guest fees for the Pasta Bar and Awards Banquet are \$20 and \$35 respectively.

## CONTESTANTS

A contestant may use a caddie, rent a cart, pull or carry her own clubs. Proper golf attire must be worn. Blue jeans, halter tops, short shorts, and tank tops are not permitted. Shirts must have collars and/or sleeves. Soft spikes only. **Cell phones and pagers are not allowed during tournament play and will result in disqualification.** Cart fees are \$20.00 daily; reservations and fees for cart rental must accompany the entry form. Information regarding caddie availability and rates is available directly through the Pro Shop.

## REGISTRATION

All contestants must register prior to play on Monday, August 2. Handicaps, cart arrangements, and dinner guests will be verified at that time.

## PRACTICE

Players are invited to play one practice round prior to August 2<sup>nd</sup>. A reduced greens fee of \$30 will be charged for the round and a player may bring or take a caddie, pull or carry her own clubs, or rent a cart for the practice round. Each player is invited to bring a guest for her practice round at the tournament rate of \$30 and is invited to use the facilities of McHenry Country Club on that day as hours permit. The following dates have been reserved for practice rounds: July 26<sup>th</sup> after 1:00 pm, July 31<sup>nd</sup> after 2:00 pm and August 1<sup>st</sup> 11:00 am. However, practice times on Sunday, August 1<sup>st</sup> will be reserved for players only. All practice rounds must be scheduled in advance through the Pro Shop staff at (815) 385-3435, who will also handle any special needs situations.

## TEE TIMES

Final tee times for the tournament will be determined by the size of the field. The morning wave will include Flights 2-6 each day and Championship Flight will tee off in the afternoon each day. The scheduling of the First Flight will be determined by the size of the field.

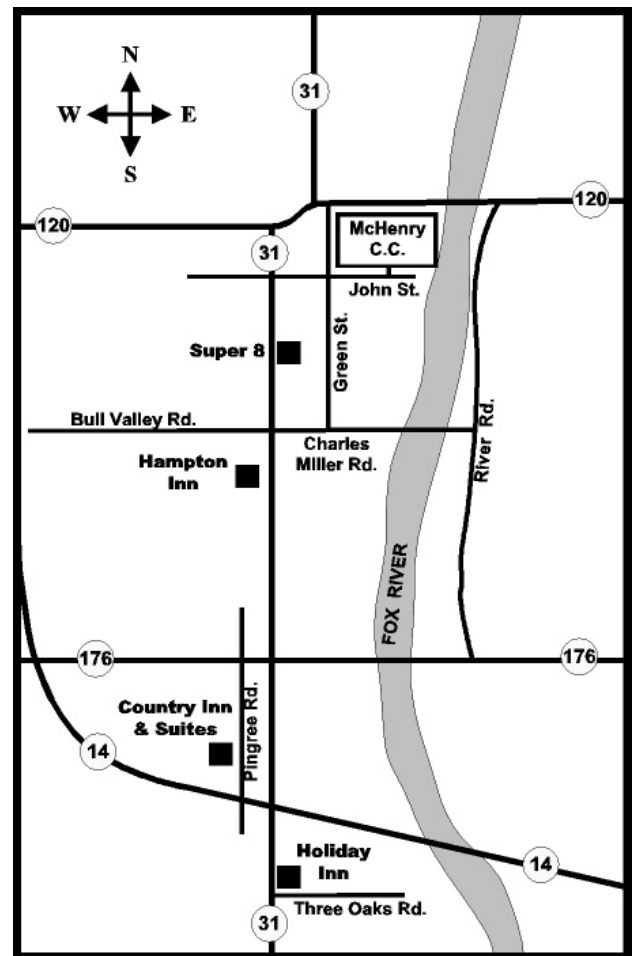
